IN THE MATTER of G.H. GILLANDERS of Kawa Kawa Bay, Clevedon R.D., Farmer a debtor ex parte MESSRS HRSTICH CURTIS SIMMONS AND ASSOCIATES of Auckland, surveyors and town planners suing as a firm, a creditor.

I, BARRY JOHN CURTIS of 43A Victoria Street, West, Auckland town planner make oath and say as follows:


1. THAT I am a partner in the abovenamed creditor firm.
2. THAT the abovenamed Debtor GEORGE HAMILTON GILLANDERS is indebted to the firm of MESSIEURS HRSTICH CURTIS SIMMONS AND ASSOCIATES in the sum of \$1,199.21 being the amount of a final Judgment obtained by it against the Debtor in the Magistrate's Court at Auckland on the 11th day of March 1969 less \$40.00 which has been paid.
3. THAT the sum of \$1,199.21 is now payable and the said GEORGE HAMILTON GILLANDERS has made no effort to pay the amount nor approached the said firm in any way.
4. THAT the said GEORGE HAMILTON GILLANDERS has committed an available act of Bankruptcy in that the firm of MESSIEURS HRSTICH CURTIS SIMMONS AND ASSOCIATES obtained a final Judgment against him in the Magistrate's Court at Auckland for the sum of \$1,239.21 and execution thereon has not been stayed and on the 29th day of

April 1969 caused to be served on the said GEORGE HAMILTON GILLANDERS a Bankruptcy Notice under the Bankruptcy Act 1908 for the amount of the final judgment less \$40.00 which has been paid and that the said GEORGE HAMILTON GILLANDERS has not complied with such Notice nor satisfied the Court that he has a counterclaim set-off or cross-demand which equals or exceeds the amount of the Judgment debt and which he could not set-up in the action in which the Judgment was obtained. The available act of Bankruptcy occurred on the 6th day of May 1969.

5. THAT the firm of MESSIEURS HRSTICH CURTIS SIMMONS AND ASSOCIATES has no security for the said debt.


