1. THE petition filed in this cause, bearing date the 14th day of May, 1969 a true copy of which is hereunto annexed marked with the letter 'A' was duly served by me on the abovenamed GEORGE HAMILTON GILLANDERS by delivering to him personally a copy thereof at 86 Lytton Road, Howick at 5.45 p.m. on the 11th day of June, 1969.

3. THE said GEORGE HAMILTON GILLANDERS is not personally known to me but I believe the person served by me as aforesaid to be the abovenamed GEORGE HAMILTON GILLANDERS by reason of the following facts:-

(a) I am informed and verily believe that GEORGE HAMILTON GILLANDERS formerly resided at Kawa Kawa Bay, Clevedon R.D. and also at 76 Hamill Road, Otara. I enquired from Ken Wallen who lives at 76 Hamill Road, Otara and from a Mrs Mason at the house next door in Hamill Road as to the whereabouts of George Hamilton Gillanders. Acting on their information and other information I went to 86 Lytton Road, Howick on the afternoon of 11th June, 1969 and spoke

to a woman who admitted she was Mrs Gillanders. She discussed with me a farm property at Kawa Kawa Bay and a fishing boat owned by her husband. She knew Ken Wallen. I returned to the same property at or about 5.45 p.m. and served a man eating his tea and who admitted he was George Hamilton Gillanders and the debtor mentioned in the petition and summons.
